Sub: The Tamil Nadu Dr.Ambedkar Law University - Temporary Affiliation granted to Pushpavathi Ammal Educational Trust, Karur District to establish a Self-Financing Private Law College in the name and style of "Dhanvanth Law College" at Karur-Erode Main Road, Athur Post, Karur, Karur District - For imparting 5 Year B.A.LL.B. and 3 Year LL.B. Degree Courses with an intake of not more than 60 students per course per year for a period of two years i.e. for the Academic Years 2026-2027 and 2027-2028- 'Certificate of Temporary Affiliation' - Issued - Reg.

I am, by direction, to inform that on perusal of G.O. 1st cited, in which the Government of Tamil Nadu have granted permission to Pushpavathi Ammal Educational Trust, Karur District to establish a Self-Financing Private Law College in the name and style of "Dhanvanth Law College" at Karur-Erode Main Road, Athur Post, Karur, Karur District and the Report of the Inspection Committee, the Syndicate of the Tamil Nadu Dr.Ambedkar Law University at its 200th Meeting held on 18.05.2026 has **RESOLVED** to grant Temporary Affiliation to 'Dhanvanth Law College' for imparting 5 Year B.A.LL.B. and 3 Year LL.B. Degree Courses with an intake of not more than 60 students per course per year for a period of Two Years i.e. for the Academic Years 2026-2027 and 2027-2028, subject to compliance of the following conditions:

- (i) The Consolidated Report pointed out the fact that the college buildings are only rental and not owned by the trust. The application of the trust encloses the rental agreement only showing that the agreement is for a period of 11 months and also for further renewal of another 11 months.

- (ii) *Clause 4.3 of the TNDALU Affiliation Regulations, 2025 makes it mandatory for the society or trust to satisfy the availability of buildings with due approval and completion certificate at the end of the second year, if incase the college started with readily available building on rent.*
- (iii) *Temporary Affiliation is granted subject to strict compliance of "The Tamil Nadu Dr.Ambedkar Law University (Affiliation and Approval of Law Colleges) Regulations, 2025 without any deviation thereto as well as obtaining necessary approval from the Bar Council of India.*
- (iv) *Without complying "The Tamil Nadu Dr.Ambedkar Law University (Affiliation and Approval of Law Colleges) Regulations, 2025 and Bar Council of India Rules of Legal Education, no admission should be made in anticipation of any approval of BCI as provided in Clause 4.4.10 of the University Regulations.*
- (v) *Temporary Affiliation is granted based on the documents submitted by letter dt.13.04.2026 by the trust. If on a later date the same is found to be incorrect or erroneous, the affiliation would stand cancelled.*
- (vi) *The apportionment of seats between the Tamil Nadu Dr.Ambedkar Law University and the Management of the "Dhanvanth Law College" is 65:35 as per G.O. (Ms.) No.75, Health & Family Welfare (ME) Department, dated 23.02.2016.*
- (vii) *The Fee structure should be in accordance with the G.O.(Ms.) No.295, Law (LS) Department, dated 02.11.2018 and G.O. (Ms.) No. 755, Law (LS) Department, dated 27.08.2024.*
- (viii) *The Chairman/Managing Trustee/Institution has to strictly adhere to "The Tamil Nadu Dr.Ambedkar Law University (Affiliation and Approval of Law Colleges) Regulations, 2025 and also fulfil Clauses 4.3, 4.4.7 and 5.12 which reads as follows:*
 - 4.3. *The Society or Trust in exceptional cases may be allowed to start the College for the first year of the programmes in a readily available building, with the condition that all other academic and administrative requirements are satisfied under the Regulations and the College shall complete the buildings with due approval and obtaining completion certificate and other requirements cited in the detailed project report at the end of the second year and the College is moved completely to the proposed permanent building in the land owned by them by the beginning of the third year, failing which the College shall not be granted renewal of affiliation until the College moves to the permanent buildings of their land. Under no circumstances, extension of time for this movement to the permanent building shall be granted by the University.*

- 4.4.7. *To the effect that the College shall obtain the eligibility approval of the appointed teaching staff from the University within three months of affiliation and shall report all changes in the teaching staff and all other changes that may affect the fulfilment of the conditions for affiliation to the University within a fortnight of changes coming into effect;*
- 5.12. *Once affiliation is granted by the University, the Law College shall thereafter obtain the necessary approval from the Bar Council of India in accordance with the conditions and procedures prescribed therein before admitting the students.*

With the above conditions, the 'Certificate of Temporary Affiliation' is issued for a period of Two Years, i.e for the Academic Years 2026-2027 and 2027-2028 and the same is enclosed herewith.
